NEED FOR THE RULE(S)

Oregon Parks and Recreation Department received a petition from landowners to add Brookings to the list of cities where overnight camping is prohibited along the ocean shore within the city limits. Residents living near Mill Beach in Brookings identify concerns over public health, risks to public safety, and impacts on the marine ecosystem along the ocean shore as reasons for proposing the closure of camping on the ocean shore in Brookings.

Currently, overnight camping is prohibited on the ocean shore within the city limits of Seaside, Cannon Beach, Manzanita, Rockaway Beach, Lincoln City, Newport, Bandon, and Gold Beach. Camping is also prohibited on the ocean shore in Clatsop and Tillamook counties, under different rules within OPRD's division 30.

Overnight camping within the city limits of Brookings has created costs for OPRD in disposal of materials left by campers. Lack of available restroom and sanitation facilities create challenging health and safety concerns. Residents requesting a rule change also expressed concern over potential fire hazard. While fires are prohibited in this area, in the past overnight campers have built fires in driftwood or other areas of concern.

Petitioners also express concern over the placement of tents and other camping equipment restricting access for other visitors to the ocean shore to enjoy other recreation activities such as walking, kite flying or picnicking.

STATEMENT IDENTIFYING HOW ADOPTION OF RULE(S) WILL AFFECT RACIAL EQUITY IN THIS STATE

The 2025-2029 Statewide Comprehensive Outdoor Recreation Plan identifies beach/ocean activities as one of the most popular recreation activities enjoyed outside of a community for individuals across racial/ethnic groups surveyed, with it ranking highest for Black and African American respondents. Eliminating overnight camping along the ocean shore in Brookings may allow for expanded day use along the ocean shore in Brookings.

The agency does not have demographic data regarding individuals currently utilizing the ocean shore in Brookings for overnight camping and would be displaced by this rule change.

FISCAL AND ECONOMIC IMPACT:

The fiscal and economic impact of prohibiting overnight camping along the ocean shore in Brookings is indeterminate.

OPRD may see a reduction in cost for removal of trash and other material left from campers. Enforcement costs for unauthorized campfires or other safety concerns may be reduced, though there may be an initial, short-term increase in enforcement costs if the prohibition goes into effect.

Nearby landowners may have a positive economic benefit from increased property values if overnight camping is prohibited. However, individuals currently camping along the ocean shore will be displaced and seek shelter in another location that may create fiscal or economic costs in those locations.

COST OF COMPLIANCE:

(c) There are no additional costs for professional services, equipment or labor for small businesses in complying with this rule.

RULE SUMMARY: Adds Brookings to the list of cities where camping is prohibited along the ocean shore within the city limits.

CHANGES TO RULE:

736-030-0020 Prohibition of Camping \P

Overnight camping, including overnight sleeping in tents, driftwood shelters, sleeping bags, recreational vehicles, trailers or automobiles, on the ocean shore within the city limits of Cannon Beach, Lincoln City, Seaside, Newport, Bandon, Gold Beach, <u>Brookings</u>, Rockaway Beach and Manzanita is prohibited.
