As someone who has been homeless on and off since 2010, and has slept in a vehicle overnight in Forest Service Ranger Station parking lots, most recently during the 2020-2024 COVID-19 global pandemic (March 2024 CDC lifted restrictions), this is not okay. I've stayed in places like Kink River Public Use Area in Alaska for the allotted 14 days before moving, or other places there like Hatcher's Pass, and camper and learned to build a fire in a wet environment with fallen brush at Resurrection Bay. I've gone to hot springs in Oregon and still make sure to pay even when the Park Services supplies no envelopes and write how many people and vehicle make and tag. In my observation, people who feel like they have to pay extortionate fees to enjoy the wilds, make sure they "earn it" by littering.
