

851-041-0050

Nurse Intern Authorized Functions

- (1) Authorized functions for the nurse intern are certified nursing assistant (CNA) 2 authorized duties pursuant to $OAR\ 851-063-0035$. \P
- (2) The nurse intern may administer medications:¶
- (a) Except for those medications listed in OAR 851-041-0060 (6)(8); ¶
- (b) When competency validated by the employing organization and; ¶
- (c) In keeping within the level of their nursing education. ¶
- (3) The nurse intern may only perform authorized functions that are assigned by their supervising RN. ¶
- (4) The nurse intern must document their performance of authorized functions in a timely, accurate, thorough, and clear manner.

Nurse Intern Prohibited Acts

A nurse intern must not:¶

- (1) Function outside of direct RN supervision;¶
- (2) Function in any supervisory role;¶
- (3) Engage independently in the nursing process; ¶
- (4) Assign any activity or plan of care intervention to another health care team member;¶
- (5) Delegate the performance of a nursing procedure in a community-based setting:¶
- (6) Administer blood or blood products;¶
- (7) Carry out procedures on central lines; or ¶
- (8) Administer chemotherapy, intravenous medications, or controlled substances.
