The OT community has lost a very dear member. OT Sybil Hedrick Park passed away on September 29th from cancer.

Sybil practiced OT for over 28 years, most recently at the Providence Sports Care Center. She served on the OTAO board (2006-2010) and the OTLB (2013-2021), including 2 years as board chair. Sybil was highly respected by her counterparts and her leadership on the board helped shape the profession of occupational therapy in the state. We will miss our amazing friend and colleague. We carry her memory in our hearts.

OTA Board Member Vacancy

The OT Licensing Board is seeking a new **OT Assistant** member to serve on its five member board. The Board is comprised of 2 OTs, 1 OTA and 2 public members. Board members are appointed by the Governor and approved by the Legislature. Board members can serve up to two 4-year terms. The application deadline is **December 13, 2024 at 5pm.**

Board member responsibilities include but are not limited to:

• Attend quarterly Board meetings, customarily held in the months of February, May, August and November. The meetings begin at 10:00am and generally last until 2:00pm. Meetings are usually held virtually with one in-person meeting per year in Portland.

• Review confidential complaints and complaint investigations, including confidential and protected health information to determine whether a licensee has violated Oregon statute or rule in the course of their practice, and impose discipline.

• Assist in responding to clinical or scope of practice inquiries that come to the Board.

The Board pays a stipend of \$178 per meeting plus reimbursement for travel to and from the in-person board meetings. The Board encourages OTA's outside of the Portland area to apply! You must reside in Oregon.

The next opening will begin formally in <u>mid-June 2025</u>, however the appointment process will begin a few months in advance. **If you are interested, please apply online on the Boards and Commissions page of the Governor's website.** For the link, click <u>here</u>.

The Governor is committed to ensuring that all Boards and Commissions represent the growing age, racial and gender diversity of the state.

Q & A: Complaints:

What are the typical types of cases the board receives? Most commonly they involve drinking and driving. Most are self-reported and some are found out through background checks required by the OTLB.

Should I file a complaint? Licensees may be reluctant to file a complaint against another licensee in fear of retribution or fear of getting someone in trouble. The Board is required to keep the name of the person who makes the complaint confidential. If the Board takes action, the complainant will be notified that public action took place. The final order will be posted on the licensee look up, reported to the National Practitioners Database and the NBCOT. <u>ORS 676.175</u>

What can the OTLB investigate? Practice by unlicensed individuals, quality of care including inappropriate or substandard, therapists working outside of the scope of practice, impaired therapists, inappropriate relationships with a patient or patient family member, criminal activity, violation of AOTA code of ethics.

What cannot the OTLB investigate*: General billing issues, complaints that a therapist was rude. Complaints about insurance companies, or facilities, such as hospitals, schools, or home health companies. Complaints about providers licensed by another regulatory Board. (The OTLB has jurisdiction over OT's or OTA's only).

What should I do if I'm arrested? Licensees are required to notify the OTLB within **10 working days** of a conviction of a misdemeanor, or an arrest for or conviction of a felony. Arrest means you've been taken into custody by a legal authority. Conviction means a formal declaration that someone is guilty of a particular crime, made by the jury, or the judge in a court of law.

*Each complaint is unique and is considered on its own merits with its specific set of circumstances. The board may conduct an investigation if the specific circumstances fall within state law.

Is your current OT Supervisor on file with the OTLB?

Any person who is licensed as an Occupational Therapy Assistant may assist in the practice of occupational therapy **only under the supervision of a licensed occupational therapist**. **339-010-0035** Before an OTA can start working they must file their OT Supervisor with the board. OTA's must update their OT Supervisor electronically through the OTLB <u>License Portal</u>. Log in and Click on Supervisor/Supervision Tab, add the name of the OT Supervisor, the Site of Supervision, the Start date and click SAVE. **The OT supervisor entered will then need to log in to their LicensePortal and change the approval status to APPROVE.** Once this done, the OT supervisor has been successfully filed with the Licensing board.

The OTLB is in process of conducting an audit of all OTA's to ensure compliance.

339-010-0021 Imposition of Civil Penalties

(m) Undertaking to act as an occupational therapy assistant independently of the supervision of an occupational therapist licensed by the Oregon Occupational Therapy Licensing Board, \$500.

Scam Alert! Please read

A notice to all licensees: The OTLB continues to receive reports from licensees that they are receiving fraudulent calls from scammers claiming to be Board staff. In some cases, the calls appear to be coming from the Board or another official agency because the scammers are "spoofing" telephone numbers. These scammers will pretend that you are under investigation with the Board and will threaten loss of license and will demand payment or personal info. We also have heard from other health boards that their board letterhead is being used so it appears to be an official letter from the board.

If you receive any of these calls or a letter and you are unsure if it is legitimate, please hang up and either call the Board at 971-673-0198 or send an <u>Email</u>.

If you are arrested you must notify the Board within **10 working days** of a conviction of a misdemeanor, or an arrest for or conviction of a felony. Email the <u>Director</u>.

To change your name: Log into the <u>License Portal</u> and submit a name change request. You can also complete the <u>name change form</u> on the website. <u>Email</u> us or fax us a copy of the legal document showing the name change.
