6. Update From State Veterinarian- Dr. Ryan Scholtz

Dr. Scholtz provided update on influenza virus present in the milk of USDA cattle. New cases are tracking back to cattle movement in Texas. Currently there are no cases in Oregon. This is not a systemic infection, and the virus is not mutating. However, spring may bring increased risk. Dr. Scholtz spoke about adapting new protocols for how reportable diseases are recorded and what to report. Dr. Scholtz had questions regarding microchipping and the need for VCPR. His DOJ representative will contact Joanna Tucker Davis for advice.

Burns provided an update on the budget and agency numbers.

i. Strategic Planning and DEI Planning- Pete Burns

iv: CET Training Review- Brooke Walker

Issue: Update.

Discussion: The group discussed expanding VCPR in large and small animal practices. Large animal issue is at the forefront. Within the next few meetings, they anticipate having developed something for board review as potential rule change.

Outcome: Select date for next meeting.

vi: CVT Workgroup Update- Ragan Borzcik,

Issue: Update

Discussion: Ragan discussed that five other states currently have alternate licensure processes. It is different across all states. Ragan would like more discussions to be had before bringing information to stakeholders. The option of developing a survey was discussed. **Outcome:** Develop a survey to send out to licensees.

vii. Rulemaking Update: Ingrid

a. OAR 875-005-0005- Definitions, and OAR 875-010-0090 Continuing Education Requirements

Issue: Bring understanding around CE requirements. **Discussion:** Issue with licensees desiring to use their initial training as CE. Cleaned up language for clarity.

Outcome: Board agreed to changes. Will move into rulemaking process.

b. OAR 875-010-0065- License and Facility Registration Renewal Procedures

Issue: Language correction needed.

Discussion: Error with wording. Replace facility owner with managing veterinarian. The managing veterinarians are responsible for renewing. **Outcome:** Changes approved by board. Will move into rulemaking process.

c. OAR 875-030-0030 Issuance of Licenses, Fees, Renewals for CVTs.

Issue: Transition from mail to electronic needs to reflect in rule. **Discussion:** Updated rules to read email instead of mail as a means of contact. Update line item (3), remove a, line item (4) received and postmarked. Hari explained how to change our late fee from \$10 to \$15. Must get approved through legislation and get ratified. Will keep \$10 in rule until approved.

Outcome: Bring back any similar language for DVM's and facilities for June board meeting. Pete will go to the legislator and put in a request in the agency request budget for 2025. Will move into rulemaking process.

d. OAR 875-040-0010- Certification of Technicians

Issue: Grammatical changes and placement of fee for clarity. **Discussion:** The board previously discussed and approved rule. Small corrections with fee placement for \$25 intern, title of rule changes from Certification of Technicians to Certification of Euthanasia Technicians, line item (1) spell out Certified Euthanasia Technicians (CET) and change line item 5(a) from hours to hour.
