





# Timeline (cont.)

### 2022:

- First Place-Based Water Plans get state-recognized
- Independent Evaluation of PBP Pilot
- State-Supported Regional Water Planning and Management Workgroup

### **2023**: HB 2010 passes, which:

- Establishes a Place-Based Water Planning Fund
- Defines how OWRD may use the fund to support Place-Based Water Planning



# "A Place-based integrated water resources plan means a plan that:

- A. Is developed for a planning area associated with waters from sources within a shared hydrologic boundary;
- B. Is developed in collaboration with a balanced representation of interests;
- C. Addresses current and future in-stream and out-of-stream needs;
- D. Includes the development of actions that are consistent with the state water resources policy and other state laws concerning the water resources of this state;
- E. Is developed using an open, equitable and transparent process that fosters public participation and meaningful engagement with environmental justice communities, consistent with the requirements of ORS 182.545;



# "A Place-based integrated water resources plan means a plan that:

- F. Is developed in consultation with the Water Resources Department and other relevant state agencies;
- G. Facilitates implementation of local water resources solutions and supports the knowledge and relationships needed to implement the solutions;
- H. Assesses actions that are compatible with local comprehensive plans;
- Strives to integrate solutions to cost-effectively achieve multiple benefits;
- J. Is consistent with the guiding principles of the integrated state water resources strategy; and
- K. Complies with the rules of the Water Resources Commission, including any rules regarding the development of place-based integrated water resources plans.



# "A Collaborative and inclusive process that is designed to:

- A. Gather information to develop a shared understanding of water resources and identify critical issues and knowledge gaps;
- B. Examine the existing and future in-stream and out-of-stream water needs for people, the economy and the environment;
- C. Identify and prioritize strategic, integrated solutions to understand and meet instream and out-of-stream water needs; and
- D. Develop, implement and update a place-based integrated water resources plan."

### 690-602-0001

### Purpose

OAR 690-602-0001 to OAR 690-602-0010 establish procedures for the Oregon Department of Water Resources administration of the Place-Based Water Planning Fund and the process and integration of place-based integrated water resources planning in Oregon's Integrated Water Resources Strategy under the provisions of ORS 537.872 through 537.873.

### 690-602-0002

### Definitions

- "Application Review Team" means all state agencies identified in ORS 537.873(7) that have the capacity to participate in application review.
- (2) "Convener" means the persons, public bodies, Indian tribes, or nonprofit organizations that bring together a balanced representation of interests to undertake place-based water planning.
- (3) "Collaborative" means the group of interested parties developing, implementing, or updating a place-based integrated water resources plan.
- (4) "Commission" means the Oregon Water Resources Commission.
- (5) "Department" means the Oregon Water Resources Department.
- (6) "Director" means the director of the Oregon Water Resources Department or the director's designee.
- (7) "Environmental Justice Community" as referenced in ORS 537.873(1) and defined in ORS 182.535.

# **Draft Rules: Definitions**

### 690-602-0002

- 12) "Place-based integrated water resources planning" as defined in ORS 537.873(1).
- 13) "Place-based integrated water resources plan" as defined in ORS 537.873(1).
- 14) "Plan" means place-based integrated water resources plan.
- 15) "Plan Review Team" means all state agencies in ORS 537.873(7) that have the capacity to participate in plan review.
- 16) "State-recognized place-based integrated water resources plan" as defined in ORS 537.873(1), means a place-based integrated water resources plan that has been reviewed by the Water Resources Commission and recognized by a commission resolution stating that the completed place-based integrated water resources plan adheres to applicable requirements.



# Recommendations/Lessons Learned

<u>Handout</u>

<u>Recommendation M</u>: The Place-Based Planning grant program should be accessible to basins with different levels of capacity and resources and be structured to provide onramps for groups through different tiers of support. Examples of these tiers include:

- Small Capacity Grants to help groups, especially those in underserved areas, prepare and assess their readiness
  to engage in the Place-Based Planning process.
- Planning Grants to help support groups in following the Place-Based Planning guidelines to develop a plan and achieve state recognition.
- Implementation Coordination Grants to help support continued engagement of planning groups as they move a state-recognized plan into action.

Consensus Vote: (20 support/neutral; 4 serious concerns; 0 actively block)



# Recommendations/Lessons Learned

Handout

**Recommendation P:** At a minimum, the Place-Based Planning grant program should enable:

- (1) Support for meaningful community engagement, at the outset and ongoing. This would include resources for broad outreach, education, multiple channels for engagement and capacity building throughout the process.
- (2) Capacity support specifically to tribal and other under-represented or marginalized communities for meaningful engagement in place-based planning.
- (3) Support for capacity and/or funding for professionals to help prepare for and execute planning according to the Place-Based Planning Guidelines. Examples include capacity for project management, creation of governance agreements, DEIJ trainings, technical plan writing, and foundational expertise in water science, ecology and biology, climate science, and water law.
- (4) Support for professional independent third-party facilitation with subject matter expertise.
- (5) Support for continued engagement of planning groups to move a state-recognized plan into implementation. This would provide capacity to planning groups to:
  - Refine plan actions and strategies,
  - Identify, prepare, and apply to funding opportunities to implement plan actions and strategies,
  - Coordinate with the interagency support team as needed,
  - Ensure that the pursuit of strategies and actions continue to represent a balanced representation of instream and out-of-stream water interests, and
  - Complete biennial reports to the Water Resources Commission on the status of implementation.
- (6) Support for planning groups to update plans when significant changes in local conditions, data availability, or climate change information indicate the need for a plan update.

Consensus Vote: (24 support/neutral; 0 serious concerns; 0 actively block)



# Recommendations/Lessons Learned



Related PBP Independent Evaluation Key Lessons Learned (OWRD contracted with the National Policy Consensus Center at Portland State University and Oregon State University's Cooperative Extension Program to conduct a joint independent <u>participatory evaluation</u> of the pilot place-based planning program.)

**Key Lesson #1:** The state's place-based integrated water planning model can be a useful tool for water resources management in some places, but the state's guiding framework requires adjustment.

**Key Lesson #4:** A situational assessment of prospective place-based planning areas needs to be done to scope out the prospective planning area's water situation as well as its collaborative and technical capacity.






### 690-602-0004 (Grant Eligibility)

The Place-Based Water Planning Fund may fund Capacity Building Grants, Planning Grants, Implementation Coordination Grants, and Plan Update Grants.

1) Eligible <u>Capacity Building Grants</u> must prepare for or assess readiness to engage in Place-Based Integrated Water Resources Planning.





# 690-602-0004 (Grant Eligibility; cont.)

- 2) Eligible <u>Planning Grants</u> must
  - a) Develop a place-based integrated water resources plan;
  - b) Be within hydrologic and size boundaries defined by the Department; and
  - c) Be open to any interested parties that live, work, or recreate within the planning area.





# 690-602-0004 (Grant Eligibility; cont.)

3) Eligible <u>Implementation Coordination Grants</u> must support the implementation of a state-recognized place-based integrated water resources plan.





# 690-602-0004 (Grant Eligibility; cont.)

4) Eligible <u>Plan Update Grants</u> must support updates to a state-recognized place-based integrated water resources plan.



### 690-602-0004 (Grant Eligibility)

The Place-Based Water Planning Fund may fund Capacity Building Grants, Planning Grants, Implementation Coordination Grants, and Plan Update Grants.
