# RAC #3 Summary



#### 690-602-0002: Definitions

#### **Summary of Changes in version 11/1**

(9) "Facilitator" means a neutral party that works to ensure a collaborative process and supports consensus building.



#### 690-602-0004: Eligible Grant Types

#### **Summary of Changes in version 11/1**

(2) Eligible Plan Development Grants must (a) develop a shared governance agreement adopted by the collaborative; and (b) develop a place-based integrated water resources plan for a planning area consistent with a shared governance agreement, using a place-based integrated water resources planning process, and following the process, content, and structure provided by the Department.



#### **Summary of Changes in version 11/1**

#### For all grant types:

"Strategic priorities identified in the state's Integrated Water Resources Strategy, the Department's strategic plan, or determined by the Director, and included in grant solicitation materials;"



#### **Summary of Changes in version 10/3**

#### **Post-Plan Coordination Grants**

- (3) Post Plan Coordination Grants shall be evaluated as follows:
  - (a) If a Collaborative's Plan has received state-recognition for the first time within the last 2 years and it has not received a Post Plan Coordination Grant previously, its application may be given priority by the application review team.



#### **Summary of Changes in version 10/3**

#### Post-Plan Coordination Grants (cont'd)

- (b) If the Collaborative's Plan received state-recognition two or more years before the application deadline, its application shall be evaluated on:
  - A. Demonstration of the pursuit of Plan strategies and actions that continue to represent a balance of instream and out-of-stream water interests and a commitment to collaboration and place-based planning principles; and



#### **Summary of Changes in version 10/3**

#### Post-Plan Coordination Grants (cont'd)

- B. Progress made towards Plan implementation, including how progress aligns with the Plan's implementation strategies and continues to represent a balance of in-stream and out-of-stream water interests;
- C. The proposed approach to public participation and engagement of environmental justice communities; and
- D. Strategic priorities identified in the state's Integrated Water Resources Strategy, the Department's strategic plan, or determined by the Director, and included in grant solicitation materials.



#### **Summary of Changes in version 10/3**

(2) "The Plan Review Team shall review plans for adherence to the definition of a place-based integrated water resources plan, placebased integrated water resources planning, and the related process, content, and structure provided by the Department. review the Plan according to the evaluation metrics provided by the Department and The Plan Review Team shall make a recommendation to the Director about state recognition of the Plan within 120 days of plan submission. If the Plan Review Team requires changes to recommend the Plan for state recognition, the Collaborative will be given an opportunity to amend its plan before a final recommendation is made."



#### **Summary of Changes in version 11/1**

"(3) A Plan may be recognized by the Commission if it meets the definition of a place-based integrated water resources plan, was developed using place-based integrated water resources planning, follows the process, content, and structure provided by the Department, and upon recommendation by the Director."



#### Summary of Changes in version 11/1

"(5) The Department, in consultation with other relevant state agencies, shall support implementation of state recognized Plans appropriate to their mission, authorities, and priorities, as capacity allows. The Department shall identify, document, and communicate to collaboratives which Plan strategies may be supported by the Department according to the Department's are consistent with an agency's mission, authorities, and priorities, and whether and how they may be supported by those agencies as resources and capacity allow.



#### **Summary of Changes in version 11/1**

"(6) Plans that achieve state recognition before the Department begins updating the state's next Integrated Water Resources Strategy shall be considered in the update. The Department, in consultation with other relevant state agencies, shall identify, and may incorporate common themes or individual strategies emerging from state-recognized Plans into updates and any associated workplans, as appropriate to consistent with the Department's mission, authorities, and priorities, and as capacity allows."



#### 690-602-0005: Match Requirements

#### **Summary of Changes in version 11/1**

(2) All applicants must demonstrate the required matching contribution has been secured or is being sought at the time of application. Department funding may not be released prior to secured commitment of the other funds. Pending match funds commitments of funding must be secured within 12 months from the date of the place-based water planning award.



#### 690-602-0003: Grant Application Process

#### **Summary of Changes in version 11/1**

- "(3) The Department shall may use an application review team to review applications based on the evaluation criteria in 690-602-0006 and may use an application review team to assist in conducting this review."
- "(5) The Director shall may make grant funding decisions based on the grant evaluation criteria in 690-602-0006 and any associated recommendations of an the application review team, availability of fund resources, Department capacity to support grantees, and received public comments."



#### 690-602-0008: Grant Agreement and Conditions

#### **Summary of Changes in version 11/1**

**Removed:** "(3) No geographic area may be served by more than one grant from the Fund at a time."

Added: "(3) The Grantee must:

- (d) Use a neutral facilitator for plan development;
- (e) Ensure a collaborative process and adherence to principles of place-based integrated water resources planning and the state's Integrated Water Resources Strategy.
- (f) Follow the process, content, and structure provided by the Department and necessary to meet the definitions of a "Place-Based Integrated Water Resources Plan" and "Place-Based Integrated Water Resources Planning".



#### 690-602-0009: Public Notice and Comment

#### **Summary of Changes in version 11/1**

- (1) Prior to the Application Review Team making a recommendation for the award of Place-Based Water Planning funding, the Department shall provide notice as follows:
  - (a) Public notice with a minimum <del>30</del>45-day public comment period.
  - (b) Written notice to county and tribal governments within the proposed planning boundary of an application.
- (2) Prior to a decision of state recognition of a plan, the Department shall provide public notice with a minimum 3045-day public comment period and report all public comments received to the Commission for consideration.

## Expanded Scope Discussion



### Rules to clarify the Department's authority to contract directly for services.

#### **Related Statute**

ORS 537.873 (6) "In addition to disbursing moneys in the fund as described in subsection (2) of this section, the Water Resources Director may use moneys in the fund to further place-based integrated water resources planning by entering into agreements or contracting for the following..."

- (a) Efforts related to interagency coordination.
- (b) Situation assessments.
- (c) The collection or development of data, data inventories or other technical information necessary for planning.



### Rules to clarify the Department's authority to contract directly for services.

#### Related Statute ORS 537.873 (6) (cont'd)

- (d) Technical assistance.
- (e) The development of guidelines and best practices.
- (f) Providing opportunities for public participation.
- (g) The development or provision of training and learning opportunities.
- (h) Holding events and gatherings.
- (i) Evaluations to identify lessons learned and areas for improvement.
- (j) Consultation with Indian tribes.
- (k) Other actions in support of place-based integrated water resources planning that benefit a specific area in this state or the state as a whole.



### Rules to clarify the Department's authority to contract directly for services.

#### **Potential Language**

"The Department shall periodically identify ways it may use moneys in the fund to most effectively further place-based integrated water resources planning as described in ORS 537.873(6)."



## Rules around Provision of Technical Assistance <u>Potential Language</u>

"The Department, in consultation with other relevant state agencies, shall develop a system for receiving, prioritizing, and responding to requests for technical assistance to support placebased integrated water resources planning."



## Rules around Program Evaluation and Improvement <u>Potential Language</u>

"The Department, in consultation with other relevant state agencies, collaboratives, and other interested parties, shall periodically conduct a program evaluation and implement strategies for improvement."



## Economic & Fiscal Impacts and Racial Equity Impacts Discussion



#### Statement of Fiscal Impact (ORS 183.335(2)(b)(E))

- (1) What <u>state agencies</u>, <u>units of local government</u> and <u>the public</u> may be economically affected by the proposed rules and what are those effects likely to be?
- (2) Will there be significant economic effect of proposed rules on businesses?



#### Statement of Fiscal Impact (ORS 183.335(2)(b)(E))

- (3) What will the cost of compliance on small businesses\* be (ORS 183.336)?
  - How many small businesses will be subject to these rules? What types of industries will these small businesses belong to?
  - What are the expected reporting, recordkeeping and administrative activities required for compliance with the proposed rules, including costs of professional services?
  - What types of equipment, supplies, labor and increased administration are required for compliance with the proposed rules?
- \* Small business means "a corporation, partnership, sole proprietorship or other legal entity formed for the purpose of making a profit, which is independently owned and operated from all other businesses and which has 50 or fewer employees" (ORS 183.310(10)(a))



#### Statement of Fiscal Impact (ORS 183.335(2)(b)(E))

- (1) What <u>state agencies</u>, <u>units of local government</u> and <u>the public</u> may be economically affected by the proposed rules and what are those effects likely to be?
  - Staff time/capacity in administration of grant fund (OWRD)
  - Provision of information/technical assistance and planning support (State Agencies, Local Government, Public)
  - Staff time/capacity as grantees and/or convening Planning Collaboratives (Local Government, Public)



#### Statement of Fiscal Impact (ORS 183.335(2)(b)(E))

- (2) Will there be significant economic effect of proposed rules on businesses?
  - Consultants as project managers, facilitators, technical writers, technical assistance providers, grantees



#### Statement of Fiscal Impact (ORS 183.335(2)(b)(E))

- (3) Cost of Compliance on Small Businesses
  - Consultants as project managers, facilitators, technical writers, technical assistance provider, grantees
  - Depends on contract with grantee; Reporting, recordkeeping and administrative activities required with normal grant administration and implementation progress reports



#### Racial Equity Impacts

#### Racial Impact Statement (ORS 183.335 (2)(b)(F))

- Who could be affected by the draft rules?
- How could the draft rules affect racial equity?



#### Racial Equity Impacts

#### Racial Impact Statement (ORS 183.335 (2)(b)(F))

- All grants will be evaluated on their proposals for engagement of environmental justice communities.
- All grant types may support building the capacity of a community to engage in relevant planning where community "means the people impacted by the water resources of the planning area, entities with an interest or obligation related to water resources or ecosystems in or impacted by the planning area, and federal, state, local, and tribal governments."



#### Racial Equity Impacts

#### Racial Impact Statement (ORS 183.335 (2)(b)(F))

- In practice, these rules are anticipated to foster more inclusive and equitable water resource management, ultimately leading to better outcomes for impacted communities.
- Consideration of state recognized Place-Based Plans in the development of the Oregon Integrated Water Resources Strategy offers the opportunity for diverse voices to have a further reaching impact into statewide planning efforts.
- No unintended adverse consequences on racial equity are expected from the rule.
