CHANGES TO RULE:

848-005-0015

Board Member Compensation

- (1) A Board member shall receive up to \$150 stipenda stipend consistent with ORS 292.495 for each day or portion thereof during which the member is engaged in the performance of official duties as follows: \$\frac{4}{2}\$ Between 30 minutes and 4 hours, \$75.\$\frac{4}{2}\$
- (b) Greater than 4 hours, \$150...¶
- (2) Performance of official duties is defined as:¶
- (a) SAttendance at scheduled meetings:¶
- (A) Board meetings, including special Board meetings via conference call or web conference, \P
- (B) Board committee meetings., rule advisory meetings, or other similar meetings establihsed by the Board: ¶
- (b) Appointments with Board staff for Board business;¶
- (c) Legislative testimony representing the Board; OR¶
- (d) Conferences and activities that the Board has requested that the member attend as its representative.¶
- (3)-Each Board members shall receive a half day stipend for each regularly scheduled Board meeting preparation. This compensation is waived if the Board member does not attend the meeting for which they have

prepared review of Board packet materials sent out prior to Board meetings.
