NEED FOR THE RULE(S)

There has been a gap in training opportunities when physical training is not readily available. This new rule will allow use of simulators to meet training requirements.

FISCAL AND ECONOMIC IMPACT:

There will be costs associated with use of the simulators at a third-party marine education and training facility. Based on a class size of three, the cost estimate is as follows: Rental of simulator with operator \$2,150, mileage reimbursement \$190, lodging \$350, per diem \$110, and two unlimited pilots serving as coach/mentor including travel costs \$1735 for a total of \$4,535 per trainee.

Up to one-half of the turns required by OAR 856-015-0011(2)(d), OAR 856-015-0035(2)(e), and OAR 856-0150035(6)(i) may be satisfied by a trainee who delivers to the Training Course Monitor and to the Board's
administrator one or more certificates evidencing satisfactory completion of a course, or courses, designed by the
Training Course Monitor to simulate the specific turns described in those rules on a vessel simulator at a
nationally recognized, independent, marine education and training facility designated by the Board. The simulator
training must have been scheduled by the Training Course Monitor.
