BISSEY AND PROBATION 7 8 9 On December 31, 2019, the Teacher Standards and Practices Commission 10 (Commission) issued a Notice of Opportunity for Hearing to John R. Bissey (Bissey) in 11 which the Commission charged him with Gross Neglect of Duty. The Notice was sent via 12 U.S. First Class Mail and U.S. Certified Mail Receipt 7018 1830 0001 6178 7015 to the 13 address on file with the Commission. The Notice designated the Commission file as the 14 record for purposes of proving a prima facie case. The Certified Mail receipt was returned to 15 the Commission signed. The first class mail was not returned to the Commission and 16 assumed delivered. The Notice of Opportunity of Hearing, dated December, 31 2019, and 17 signed by Anthony Rosilez, Executive Director, stated: 18 "IF A REQUEST FOR HEARING IS NOT RECEIVED WITHIN THIS 21-DAY 19 PERIOD, YOUR RIGHT TO A HEARING SHALL BE CONSIDERED WAIVED 20 UNLESS YOUR FAILURE TO REQUEST A HEARING WAS BEYOND YOUR 21 REASONABLE CONTROL. IF YOU DO NOT REQUEST A HEARING, WITHDRAW 22 YOUR REQUEST FOR HEARING, IF YOU FAIL TO APPEAR AT A HEARING, OR 23 NOTIFY THE COMMISSION THAT YOU WILL NOT APPEAR AT HEARING, THE 24 COMMISSION WILL ADOPT AN ORDER OF DEFAULT WHICH MAY INCLUDE 25 THE REVOCATION OR SUSPENSION OF YOUR LICENSE OR OTHER 26 DISCIPLINE." 27 28 Bissey did not request a hearing. The Commission, therefore, finds Bissey to be in default 29 and enters the following findings of fact, conclusions of law, and final order, based on the 30 files and records of the Commission concerning this matter. 31 32 FINDINGS OF FACT 33 1. The Commission has licensed Bissey since April 15, 2011. Bissey holds a Preliminary 34 Teaching License, with endorsements in Biology (PK-12); Legacy Middle Level (PK-12); 35 36 and Integrated Science (PK-12), valid from March 21, 2017, through October 23, 2020. 37 Bissey also hold an Administrator License, with an endorsement in Principal (PK-12), 38 valid from August 12, 2019 through October 23, 2022. During all relevant times, Bissey

i	was employed by the Prospect School District (PSD).
2	
3	2. On November 15, 2018, the Commission received a report from the PSD indicating
4	Bissey may have committed acts which constitute gross neglect of duty and/or gross
5	unfitness. Specifically, Bissey inappropriately shared confidential student records.
6	
7	3. Investigation determined that on or about October 22, 2018, Bissey contacted and
8	shared confidential information with a news media journalist. Information received
9	indicates Bissey forwarded school district email correspondence that included
10	information and attachments containing confidential student information. This
11	unauthorized disclosure violated School district policy and Federal Educational Rights
12	and Privacy Act (FERPA) regulations.
13	CONCLUSIONS OF LAW
14	The conduct described above constitutes gross neglect of duty in violation of ORS
15	342.175(1)(b); OAR 584-020-0040(4)(n) as it incorporates OAR 584-020-0010(1) (Recognize
16	the worth and dignity of all persons and respect for each individual), OAR 584-020-0010(5)
17	(Use professional judgment), OAR 584-020-0025(2)(c) (Using and maintaining student
18	records as required by federal and state law and district policies and procedures), OAR 584-
19	020-0025(2)(e) (Using district lawful and reasonable rules and regulations); OAR 584-020-
20	0040(4)(0) as it incorporates OAR 584-020-0035(1)(a) (Keep the confidence entrusted in the
21	profession as it relates to confidential information concerning a student and the student's
22	family).
23	
24	The Commission's authority to impose discipline in this matter is based upon ORS
25	342.175.
26	FINAL ORDER
27	The Commission hereby issues a public reprimand upon John R. Bissey's Oregon
28	educator license and places John Bissey on probation for two (2) years of probation from
29	the date this order is signed.
