1 BEFORE THE TEACHER STANDARDS AND PRACTICES COMMISSION 2 OF THE STATE OF OREGON 3 In the Matter of the STIPULATION OF FACTS AND 4 **Educator License of** FINAL ORDER OF PUBLIC 5 SCOTT E. NOPP REPRIMAND 6 7 On March 13, 2019, the Teacher Standards and Practices Commission 8 (Commission) received a report from the Eugene School District (ESD) indicating 9 licensed educator Scott E. Nopp (Nopp) may have committed acts which constitute gross 10 neglect of duty and/or gross unfitness. 11 After review of the matters alleged, Nopp and the Commission agree that their 12 respective interests, together with the public interest, are best served by a stipulation to 13 certain facts and the imposition of a Public Reprimand. 14 This Order sets forth the facts upon which the parties have agreed and the 15 sanction to be imposed. Nopp stipulates that there are sufficient facts contained in the 16 Commission's files and records to support the findings of fact and conclusions of law set 17 forth below. In entering into this stipulation, Nopp waives the right to a hearing to 18 contest the findings of fact, conclusions of law and order set forth below. 19 By signing below, Nopp acknowledges, understands, stipulates, and agrees to the 20 following: (i) he has been fully advised of his rights to notice and a hearing to contest the 21 findings of fact, conclusions of law, and order set forth below, and fully and finally 22 waives all such rights and any rights to appeal or otherwise challenge this Stipulation of 23 Facts and Final Order of Public Reprimand (Stipulation and Final Order); (ii) this 24 Stipulation and Final Order is a public document and disclosed to the public upon 25 request by the Commission; (iii) this Stipulation and Final Order is contingent upon and 26 subject to approval and adoption by the Commission. If the Commission does not 27 approve and adopt this Stipulation and Final Order, then neither Nopp nor the 28 Commission are bound by the terms herein; (iv) he has fully read this Stipulation and 29 Final Order, and understands it completely; (v) he voluntarily, without any force or 30 duress, enters into this Stipulation and Final Order and consents to issuance and entry of 31 the Stipulated Final Order below; (vi) he states that no promise or representation has 32 been made to induce him to sign this Stipulation and Final Order; and (vii) he has

consulted with an attorney regarding this Stipulation and Final Order and has been fully

advised with regard to his rights thereto, or waives any and all rights to consult with an

1 attorney prior to entering into this Stipulation and Final Order and issuance and entry of 2 the Stipulated Final Order below. 3 STIPULATION OF FACTS 4 1. The Commission has licensed Nopp since February 1, 2000. Nopp currently 5 holds a Substitute Teaching License, with an endorsement in Substitute Any Specialty (PK-12), valid from April 17, 2017, through February 23, 2021. During 7 all relevant times, Nopp was employed by the Eugene School District (ESD) for 8 substitute teaching services. During the reported incident, Nopp was providing 9 substitute services to the ESD at James Madison Middle School (JMMS). 10 11 2. On March 13, 2019, the Commission received a report from the ESD indicating 12 Nopp had engaged in conduct that may be considered gross neglect of duty 13 and/or gross unfitness. Specifically, the ESD reported Nopp engaged in 14 inappropriate physical contact with a student. 15 16 3. Investigation determined that on or about February 11, 2019, Nopp interacted 17 with a student who was talking and disrupting class. The student failed to 18 respond to Nopp's direction and began to bully another student. During the 19 interaction, Nopp grabbed the student by the arm / wrist while he discussed the 20 student's behavior. The student was upset that Nopp was physically holding him 21 and later reported this to the administration. The ESD investigation determined 22 that Nopp had violated local policy. In Nopp's interview with the Commission 23 investigator, Nopp suffers from Multiple Sclerosis, and in Nopp's interview with 24 the Commission investigator, Nopp acknowledged that his condition may have 25 affected his decision to hold onto the student. Nopp's intentions were not to make 26 the student uncomfortable, and Nopp recognizes that touching students 27 physically is not appropriate unless necessary to protect the student or others. 28 29 IT IS SO STIPULATED: 7/7/2022 Date 02/09/2022 30 31 32 33

6	employees, or visitors to the school, except as permitted under ORS 339.250).

8	The Commission's authority to impose discipline in this matter is based upon
9	ORS 342.175.
0	ORDER
1	The Commission adopts and incorporates herein the above findings of fact and
2	conclusions of law, and based thereon, imposes a Public Reprimand on Scott Nopp's
3	Oregon educator license.
