

1 Subjects (PK-12) and English to Speakers of Other Languages (PK-12), valid from
2 June 8, 2021, through June 7, 2024.

- 4 2. On October 27, 2021, the Commission received information from the Oregon
5 Department of Human Services (DHS) reporting Cancino allegedly engaged in an
6 inappropriate sexual relationship with a minor for approximately ten years. On
7 November 9, 2021, the Commission received a misconduct report from the
8 Woodburn School District (WSD) indicating Cancino may have committed acts
9 which constitute gross neglect of duty and/or gross unfitness. The district
10 reported Cancino was being investigated for allegations of sexual abuse.

- 12 3. Investigation found that on October 29, 2021, the WSD placed Cancino on
13 administrative leave after the District learned of the allegations of sexual conduct
14 against Cancino.

- 16 4. Investigation found that on unspecified dates from approximately 2000 to 2010,
17 Cancino engaged in sexual conduct with a minor on approximately six occasions.

19 CONCLUSIONS OF LAW

20 Jaime V. Cancino's conduct as described in section four (4) above constitutes
21 gross neglect of duty in violation of ORS 342.175(1)(b); OAR 584-020-0040(4)(f) (*Any*
22 *sexual conduct with a student*) as defined by OAR 584-020-0005(8) and ORS
23 339.370(12)(a).

24 Jaime V. Cancino's conduct as described in section four (4) above, constitutes
25 gross unfitness in violation of ORS 342.175(1)(c); OAR 584-020-0040(3)(c) and (d) as
26 defined by OAR 584-020-0040 (5) (*Gross unfitness is any conduct which renders an*
27 *educator unqualified to perform his or her professional responsibilities*), and OAR 584-
28 020-0040(5)(e) (*Admission of or engaging in acts constituting criminal conduct, even*
29 *in the absence of a conviction*).

30 The Commission's authority to impose discipline in this matter is based upon
31 ORS 342.175.


