The Notice was sent via U.S. First Class Mail and U.S. Certified 11 Mail Receipt 7010 2780 0000 2187 7116 to the address on file with the Commission. The certified 12 mail was signed for on October 11, 2011. The Notice of Opportunity of Hearing, dated October 4, 13 2011, and signed by Victoria Chamberlain, Executive Director, stated: 14 15 "You, Richard Wayne Knode, are entitled to a hearing on the proposed action of the 16 Commission. If you want a hearing, you must file a written request for a hearing with 17 the Commission within 60 days of the date of this notice. Attached to this notice is a 18 copy of the procedures, right of representation and other rights of parties relating to the 19 conduct of a hearing as required under ORS 183.413(2)" 20 21 Knode did not request a hearing. The Commission, therefore, finds Knode to be in default and 22 enters the following findings of fact, conclusions of law and order, based on the files and 23 records of the Commission concerning this matter. 24 25 FINDINGS OF FACT 26 27 1. On or about January 21, 2011, Knode applied to the Commission for reinstatement of his 28 surrendered license. Knode had been licensed by the Commission since March 15, 1973, and last 29 held a Standard Administrator License issued March 11, 2003, valid through May 19, 2008, with a 30 Standard Administrator Endorsement. 31 32 2. Knode voluntarily surrendered his license on November 14, 2005, after subjecting a female 33 educator whom he directly supervised, to sexual advances together with verbal and physical 34 conduct of a sexual nature. 35 36 /// 37

2	3. The Commission denies Knode's reinstatement application for the following reasons:
3	a. The information Knode submitted, along with his reinstatement documents, do not establish
4	that he possesses good moral character, trustworthiness, or physical and mental health to
5	hold an educator's license. Pursuant to OAR 584-050-0018(4)(d) (Letters of
6	recommendations from educator colleagues are insufficient alone to establish fitness for
7	licensure following a revocation. The educator must be clear regarding what proactive
8	steps have been taken to ensure to the Commission that the conduct that resulted in the
9	revocation is highly unlikely to occur again.)
0	CONCLUSIONS OF LAW
2	The information submitted by Richard Wayne Knode in support of his license renewal failed to
4	establish his fitness to serve as an educator as required by ORS 342.143(2) and OAR 584-050-0018(3).
5	The above described conduct provides the Commission with evidence of Knode's lack of fitness to
6	serve as an educator pursuant to OAR 584-050-0006(3)(d) (The Executive Director has evidence that
.7	the applicant may lack fitness to serve as an educator).

22 23 24	The application for reinstatement of the revoked teaching license of Richard Wayne Knode is DENIED.
