8	On October 16, 2015, the Teacher Standards and Practices Commission
9	(Commission) issued a Notice of Opportunity for Hearing to Jody Lee Allard (Allard) in
10	which the Commission charged him with Gross Neglect of Duty and Gross Unfitness.
11	The Notice was sent via U.S. First Class Mail and U.S. Certified Mail Receipt 7015 0640
12	000475399800 to the address on file with the Commission. The Notice designated the
13	Commission file as the record for purposes of proving a prima facie case. The Certified
14	Mail receipt was returned signed to the Commission on October 21, 2015, and the
15	regular first class mail was not returned to the Commission and assumed delivered. The
16	Notice of Opportunity of Hearing, dated October 16, 2015, and signed by Victoria
17	Chamberlain, Executive Director, stated:
18 19 20 21 22 23 24 25	"IF A REQUEST FOR HEARING IS NOT RECEIVED WITHIN THIS 21-DAY PERIOD, YOUR RIGHT TO A HEARING SHALL BE CONSIDERED WAIVED UNLESS YOUR FAILURE TO REQUEST A HEARING WAS BEYOND YOUR REASONABLE CONTROL. IF YOU DO NOT REQUEST A HEARING OR IF YOU FAIL TO APPEAR AT A HEARING, THE COMMISSION WILL ADOPT AN ORDER OF DEFAULT WHICH MAY INCLUDE THE REVOCATION OR SUSPENSION OF YOUR LICENSE OR OTHER DISCIPLINE."
26	Allard did not request a hearing. The Commission, therefore, finds Allard to be in
27	default and enters the following findings of fact, conclusions of law, and final order,
28	based on the files and records of the Commission concerning this matter.
29	FINDINGS OF FACT
30	1. Jody Lee Allard has been licensed by the Commission since November 4, 1998.
31	Allard's Standard Teaching License, with endorsements in Basic Mathematics (018)
32	and Standard Exceptional Learner II (018), was valid from January 21, 2012,
33	through January 20, 2017. During all relevant times, Allard was employed by the
34	Bethel School District.
35	2. On or about April 17, 2014, a warrant was issued for Allard's arrest charging Allard
36	with the crimes of Commercial Sex-Encouraging Child Sex Abuse. On May 11, 2014,
37	Allard was arrested in Colorado and extradited back to Oregon. On July 30, 2014,

1	Allard was charged with ten counts of Encouraging Child Sex Abuse in the First
2	Degree and ten counts of Encouraging Child Sex abuse in the second degree. On
3	December 18, 2014, Allard plead guilty to and was subsequently convicted in the
4	Lane County Circuit Court of three counts of Encouraging Child Sex Abuse in the
5	First Degree, ORS 163.684, a class B felony and one count of Encouraging Child Sex
6	Abuse in the Second Degree, ORS 163.686, a class C Felony. Allard was sentenced to
7	60 months in prison, followed by probation, required to undergo sex offender
8	evaluation and treatment, and Allard must register as a sex offender.
9	3. Allard's convictions arose from allegations that included that Allard possessed child

3. Allard's convictions arose from allegations that included that Allard possessed child pornography and shared / exchanged child pornography over the internet.

CONCLUSIONS OF LAW

Allard's convictions constitutes gross neglect of duty in violation of ORS 342.175(1)(b); OAR 584-020-0040(4)(n) as it incorporates OAR 584-020-0010(5) (Use professional judgment); OAR 584-020-0040(1)(bb) (ORS 163.684-Encouraging Child Sex Abuse in the First Degree), and OAR 584-020-0040(1)(cc) (ORS 163.686-Encouraging Child Sex Abuse in the Second Degree). This conduct also constitutes gross unfitness in violation of ORS 342.175(1)(c); OAR 584-020-0040(5)(c) (Conviction of violating any federal, state, or local law. A conviction includes any final judgment of conviction by a court whether as the result of guilty plea, no contest plea or any other means); OAR 584-020-0040(5)(d) (Commission of an act listed in OAR 584-020-0040(1); and OAR 584-020-0040(5)(e) (Admission of or engaging in acts constituting criminal conduct, even in the absence of a conviction).

Pursuant to ORS 342.175(3) and OAR 584-020-0040(1) the Teacher Standards and Practices Commission must revoke your license and your right to apply for a license based on your conviction of any of the crimes listed in ORS 342.143(3)(a), or the substantial equivalent of any of those crimes.

Furthermore, the conduct underlying Allard's convictions constitutes gross neglect of duty in violation of ORS 342.175(1)(b); OAR 584-020-0040(4)(n) as it incorporates OAR 584-020-0010(5) (*Use professional judgment*); OAR 584-020-0040(4)(k) (*Violation of any rule or order of the Commission*); OAR 584-020-0040(4)(o) as it incorporates OAR 584-020-0035(3)(a)(*Maintain the dignity of the*

1	profession by respecting and obeying the law, exemplifying personal integrity and
2	honesty). Additionally, your conviction and conduct related to your conviction
3	constitute "gross unfitness" in violation of ORS 342.175(1)(c); OAR 584-020-0040(3)(a)
4	and (d) as defined by OAR 584-020-0040 (5) ("Gross unfitness is any conduct which
5	renders an educator unqualified to perform his or her professional responsibilities").
6	
7	The Commission's authority to impose discipline in this matter is based upon ORS
8	342.175.
9	FINAL ORDER
10	The Commission hereby revokes Jody Lee Allard's teaching license and his right
11	to apply for licensure.
