14	sanction to be imposed. Bunch sti	pulates that the	re is sufficient evidence in the Commission's	
15	files and records to support the fin	idings of fact, co	nclusions of law, and order set forth below.	
16	By signing below, Bunch ac	cknowledges, un	derstands, stipulates, and agrees to the	
17	following: (i) he has been fully ad-	vised of his right	s to notice and a hearing to contest the

In entering into this stipulation, Bunch waives the right to a hearing to contest the findings of fact,

conclusions of law and order set forth below.

STIPULATION OF FACTS

- 1. The Commission has licensed Bunch since May 19 2011. Bunch currently holds an Initial I Teaching License issued May 19, 2011, with endorsements in Biology (HS ML) and Multiple Subjects (MDLVL), which expires on April 15, 2015. During all relevant times, Bunch was employed by Central Catholic High School, a private school located in Portland Oregon.
- 2. On September 10, 2012, the Commission received a complaint from the administration of Central Catholic High School indicating Bunch may have committed acts which constitute gross neglect of duty. Subsequent investigations determined that during 2011 2012, Bunch engaged in the following behaviors: Employed students to work on his private residence. Bunch engaged in verbal conduct of a sexual nature with students. The verbal conduct included having conversations with students regarding the students' sexual activities and sharing Bunch's own sexual stories with students.
