2 by the North Santiam School District.
3 2. On or about February 27, 2014, Temple coached and chaperoned a school
4 sponsored, State Wrestling Tournament in Portland, Oregon where Temple
5 supervised student athletes. Investigation determined, and by Temple's own
6 admission, Temple occasionally consumed alcoholic beverages (beer) at a meal,
7 at a social gathering, and in a hotel room while Temple remained on duty as
8 chaperone and school representative responsible for student athletes. It was
9 further determined that Temple observed nineteen year old, volunteer coach
10 Redman consume alcohol during the event. While Temple may not have known
11 Redman's age, Temple was responsible for the coaching staff and failed to
12 confirm Redman was of legal drinking age.

CONCLUSION OF LAW

On or about February 27, 2014, Temple violated professional standards as described above. This conduct constitutes gross neglect of duty in violation of ORS 342.175(1)(b); OAR 584-020-0040(4)(n) as it incorporates OAR 584-020-0010(5) (*Use professional judgment*), OAR 584-020-0020(2)(d) (*Skill in the supervision of students*); and OAR 584-020-0040(4)(g) (*Appearing on duty or at any district-sponsored activity while under the influence of alcohol or any controlled substance*).

The Commission's authority to impose discipline in this matter is based upon ORS 342.175.
