9		On May 31, 2016, the Teacher Standards and Practices Commission
10	(Co	ommission) issued a Notice of Opportunity for Hearing to Jonathan Michael Peachey
11	(Pe	eachey) in which the Commission charged him with Gross Neglect of Duty and Gross
12	Un	fitness. The Notice was sent via U.S. First Class Mail and U.S. Certified Mail Receipt

14	des	signated the Commission file as the record for purposes of proving a prima facie case.
15	Th	e Certified Mail was returned to the Commission as "unclaimed". The regular first
16	cla	ss mail was not returned to the Commission and is assumed to have been delivered.
17	Th	e Notice of Opportunity of Hearing, dated May 31, 2016, and signed by Victoria
18	Ch	amberlain, Executive Director, stated:

26 27	Pe	achey did not request a hearing. The Commission, therefore, finds Peachey to be in
28	de	fault and enters the following findings of fact, conclusions of law, and final order,
29	ba	sed on the files and records of the Commission concerning this matter.
30		FINDINGS OF FACT
31	1.	Jonathan Michael Peachey has been licensed by the Commission since August 13,
32		2003. Peachey's Initial II Teaching License, with endorsements in ESOL (ML/HS,
33		ECE/ELE L), ESOL/Bilingual (ML/HS, ECE/ELE L), and Spanish (HS) is valid from
34		August 14, 2013, through July 4, 2017. During all relevant times, Peachey was
35		employed by the West Linn-Wilsonville School District.
36	2.	On February 3, 2016, Peachey pled guilty to, and was convicted of, two counts of
37		Sexual Abuse in the Third Degree (ORS 163.415), a class A Misdemeanor. Peachey

1	was sentenced to sixty days in jail, 36 months of supervised probation, and required
2	to register as a sex offender.
3	3. Peachey's convictions arose from allegations that on or about August 2015, through
4	September 2015, Peachey subjected students, under the age of 18, to sexual contact.
5	Investigation determined Peachey provided minor aged students with alcoholic
6	beverages, slept in the same bed as students, spooned with students, touched the
7	penis of the students, discussed oral sex with the students, and asked these students
8	if they were sexually aroused.
9	CONCLUSIONS OF LAW
10	Peachey's convictions constitutes gross neglect of duty in violation of ORS
11	342.175(1)(b); OAR 584-020-0040(4)(n) as it incorporates OAR 584-020-0010(5) (Use
12	professional judgment); and OAR 584-020-0040(1)(m) (ORS 163.415 –Sexual Abuse in
13	the Third Degree). This conduct also constitutes gross unfitness in violation of ORS
14	342.175(1)(c); OAR 584-020-0040(5)(e) (Admission of or engaging in acts constituting
15	criminal conduct, even in the absence of a conviction). Additionally, Peachey's
16	convictions constitute "gross unfitness" in violation of ORS 342.175(1)(c), OAR 584-
17	020-0040(3)(a) and (d) as defined by OAR 584-020-0040 (5) ("Gross unfitness is any

responsibilities").

Pursuant to ORS 342.175(3) and OAR 584-020-0040(1) the Teacher Standards and Practices Commission must revoke Peachey's license and Peachey's right to apply for a license based on conviction of any of the crimes listed in ORS 342.143(3)(a), or the

conduct which renders an educator unqualified to perform his or her professional

23 substantial equivalent of any of those crimes.

Furthermore, the conduct underlying Peachey's indictments and convictions constitutes gross neglect of duty in violation of ORS 342.175(1)(b); OAR 584-020-0040(4)(n) as it incorporates OAR 584-020-0010(5) (*Use professional judgment*); OAR 584-020-0040(4)(k)(*Violation of any rule or order of the Commission*); OAR 584-020-0040(4)(f) (*Any sexual conduct with a student*) as defined by OAR 584-020-0005(5); and OAR 584-020-0040(4)(0) as it incorporates OAR 584-020-0035(1)(c)(A) (*Not demonstrating or expressing professionally inappropriate interest in a student's personal life*), OAR 584-020-0035(1)(c)(D) (*Honoring appropriate adult boundaries*

with students in conduct and conversations at all times); and OAR 584-020-
0035(3)(a)(Maintain the dignity of the profession by respecting and obeying the law,
exemplifying personal integrity and honesty). Additionally, Peachey's convictions and
conduct related to Peachey's convictions constitute "gross unfitness" in violation of ORS
342.175(1)(c); OAR 584-020-0040(3)(a) and (d) as defined by OAR 584-020-0040 (5)
("Gross unfitness is any conduct which renders an educator unqualified to perform his
or her professional responsibilities").
The Commission's authority to impose discipline in this matter is based upon ORS
342.175.
FINAL ORDER
The Commission hereby revokes Jonathan Michael Peachey's Oregon educator
license and his right to apply for an Oregon educator license.
