Terry Kim Gillies holds a Standard Administrative License endorsed for 15 administrator and superintendent and valid from June 5, 1998 to May 15, 2003. 16 2. On or about November 15, 1996, Gillies approved payment to his wife as a DJ at 17 a Newport Middle School dance where Mr. Gillies is principal. Mr. Gillies obtained \$200 in 18 cash (proceeds of a school dance held on November 15, 1996) and disbursed those funds in cash 19 to his wife in violation of the District expenditure policy. 20 3. On or about December 20, 1996, Mr. Gillies approved an expenditure request for 21 \$369 to pay his wife for performing disc jockey services at a Newport Middle School dance on 22 that date. A portion of this amount (\$69) was reimbursement for prizes awarded to students at 23 the dance.

1	4. On or about March 24, 1998, Gillies signed a Stipulated Final Order with the
2	Government Standards and Practices Commission for violation of ORS 244.040(1)(a) and
3	ORS 244.120 and was required to pay \$769 in fines and forfeiture.
4	Terry Gillies enters into this Stipulation of Facts with knowledge that the Teacher
5	Standards and Practices Commission will issue a Public Reprimand. This Stipulation is
6	contingent upon approval and adoption of the Order by the Commission. If the Commission
7	does not adopt this Order, neither Mr. Gillies nor the Commission are bound by these
8	stipulations and MR. Gillies retains all rights to a hearing on the allegations.
