2 **STIPULATION OF FACTS**

3 1. The Commission issued a Transitional Teaching License to Mr. Lian on  
4 October 7, 1999, valid until October 7, 2002. On May 13, 2003, the Commission issued  
5 a 30-day extension to Mr. Lian's Transitional Teaching License based upon application  
6 and supporting request from Camas Valley School District.

7 2. Mr. Lian was employed as a teacher for Camas Valley High School, Camas  
8 Valley School District, from September 2001, to June 2003.

9 3. Mr. Lian knowingly served without a license from October 7, 2002, to May 12,  
10 2003.

11 4. On July 12, 2002, Mr. Lian was convicted of Possession of a Controlled  
12 Substance (marijuana) in and for the Salina City Justice Court, County of Sevier, State  
13 of Utah.

19 **CONCLUSIONS OF LAW**

20 Trevor Jay Lian knowingly failed to maintain a valid teaching license pursuant to  
21 OAR 584-050-0030(1). This misconduct constitutes Gross Neglect of Duty in violation  
22 of OAR 584-020-0040(4)(c). Trevor Jay Lian violated OAR 584-020-0040(5)(c)  
23 regarding his conviction for Possession of a Controlled Substance. This misconduct  
24 constitutes Gross Unfitness. The Commission's authority to impose discipline in this  
25 matter is based upon ORS 342.175.

2 **ORDER**

3 The Commission adopts the above findings of fact and suspends Trevor Jay  
4 Lian's right to apply for a teaching license from October 7, 2003, to May 12, 2004. At  
5 the end of the suspension period Mr. Lian shall be eligible to submit application for an  
6 Initial Teaching License. Mr. Lian shall submit a complete application pursuant to OAR  
7 584-050-0015(3) together with supporting documentation and fees.
