The Notice was sent via U.S. First 11 Class Mail and U.S. Certified Mail Receipt 7006 0810 0001 4602 2104 to the address obtained by the 12 13 Commission. The U.S. First Class Mail was signed by Lola Sierra, Coffee Creek Correctional Facility and returned to the Commission on December 12, 2007. The Notice of Opportunity of Hearing, dated 14 December 10, 2007, and signed by Victoria Chamberlain, Executive Director, stated: 15 "You, Curtis Neal Buell, are entitled to a hearing on the proposed action of the 16 Commission. If you want a hearing, you must file a written request for a hearing with 17 18 the Commission within 21 days of the date of this notice. Attached to this notice is a copy of the procedures, right of representation and other rights of parties relating to the 19 conduct of a hearing as required under ORS 183.413(2)." 20 21 Mr. Buell did not request a hearing. The Commission, therefore, finds 22 Mr. Buell to be in default and enters the following findings of fact, conclusions of law and order, 23 24 based on the files and records of the Commission concerning this matter. **FINDINGS OF FACT** 25 1. Mr. Buell has been licensed by the Commission since August 2, 2004. The Commission 26 issued Mr. Buell an Initial I Teaching License on August 2, 2004, valid until June 30, 2008, with 27 28 Chemistry and Multiple Subjects Endorsements. 2. On August 22, 2007, in the Circuit Court of the State of Oregon for the County of Lane, 29 Mr. Buell was convicted of four (4) counts of Sex Abuse in the Second Degree. This conviction 30 constitutes gross neglect of duty in violation of OAR 584-020-0040(1)(n) and ORS 163.425. 31 3. On August 22, 2007, in the Circuit Court of the State of Oregon for the County of Lane, 32
