The district did not include the documentation as required under 17 OAR 584-050-0020. Subsequently, the district submitted the documentation on October 18 17, 2006. Under OAR 584-050-0020, the Commission informed the educator of intent to 19 suspend the license on the basis of such report. The Executive Director took action to 20 notify Susan Ramirez of intent to suspend her license, and to inform her of her 21 22 opportunity for hearing by letter dated December 1, 2006. The letter was sent by Certified Mail—Return Receipt Requested #7005 1160 0001 0494 2727. The receipt was 23 signed by Dan Ramirez on December 2, 2006, and returned to TSPC. Susan Ramirez did 24 not request a hearing. 25 26 Susan Ramirez did not request a hearing within the time required by the notice. Based on 27 the foregoing, the Commission finds Susan Ramirez to be in default and enters the 28 following findings of fact, conclusion of law and order based on the Commission's files 29 and records. 30 31 32 FINDINGS OF FACT 33 34 1. Susan Ramirez was employed as a teacher for the Tigard-Tualatin School District during the 2004-2005 and 2005-2006 school years. 35 36 37 Susan Ramirez resigned from her teaching position in violation of her 38 employment contract without first providing 60 days' prior notice to the district. On September 1, 2006, Susan Ramirez submitted a letter of resignation to the Director of 39 Human Resources in Tigard-Tualatin School District. 40 41

Meeting in regular session on September 19, 2006, the Tigard-Tualatin

School District Board took action to seek a suspension of Susan Ramirez's teaching

license for the balance of the 2006-07 school year.
