29	2. On July 7, 2008, in the Circu	it Court of the State of Oregon for Marion County, you pled
30	guilty, and were convicted of Sexu	ual Abuse 3. This conviction constitutes gross neglect of duty in
31	violation of OAR 584-020-0040(1)(ı	m) and ORS 163.415, Sexual Abuse in the Third Degree.

I	CONCLUSIONS OF LAW
2	Mr. Molan's conviction of Sexual Abuse 3 constitutes gross neglect of duty in violation of OAR
3	584-020-0040(1)(m) and ORS 163.415. The Commission is required to revoke the Basic Teaching
4	License issued to Mr. Molan and revoke his right to apply for a license pursuant to ORS 342.175(2).
5	ORDER
6	The Commission hereby revokes Colby Lee Molan's Basic Teaching License and revokes his right to
7	apply for a teaching license.
